- A body registered under the Financial Corporations Act 1974.
- The trustee of:
 - i. A superannuation fund; or
 - ii. An approved deposit fund; or
 - iii. A pooled superannuation trust; or
 - iv. A public sector superannuation scheme.

(Within the meaning of the Superannuation Industry (Supervision) Act 1993 (Cth) and the fund, trust or scheme has net assets of at least \$10 million.)
