



# Refer a Friend Offer

Terms & Conditions - VFSC

<p><b>1. Interpretation</b></p>	<p>1.1. <b>Definitions:</b> For the purpose of this Agreement, the following terms shall have the meaning ascribed to them herein, unless the context otherwise requires:</p> <p>1.2. <b>Approved Account</b> - means an account that has been verified at Fusion Markets' sole discretion.</p> <p>1.3. <b>Stream</b> - refers to the two available options within the RAF promotion: Reduced Commissions Stream or Bonus Stream.</p> <p>1.4. <b>Reduced Commissions Stream</b> - refers to the discount on trading commissions.</p> <p>1.5. <b>Bonus Stream</b> - refers to the monetary bonus paid to both the Referrer and the Referee based on the deposit and trading activity.</p> <p>1.6. <b>Referrer</b> - existing client who refers a new client to Fusion Markets</p> <p>1.7. <b>Referee</b> - new client who is referred to Fusion Markets by an existing client.</p> <p>1.8. <b>Offer Duration</b> - means the promotional period in clause 2.</p> <p>1.9. <b>Lot</b> - means 100,000 units of the base currency. This is the default measurement of trade sizes in forex.</p> <p>1.10. <b>Offer, Promotion, RAF</b> - means this Refer a Friend promotion which is presented to you under these Terms.</p> <p>1.11. <b>Fusion Markets</b> - means the promoter in clause 3.</p> <p>1.12. <b>Terms and Conditions</b> - means the applicable terms and conditions and associated documents that govern your account with Fusion Markets.</p> <p>1.13. <b>You, your or yours</b>- means you, if you meet the criteria of an Eligible Client under clause 5 of these Offer Terms.</p> <p>1.14. <b>Wholesale Client</b>- means a client pursuant to section 761G(7c) of the Corporations Act 2001.</p>
<p><b>2. Promotional Period</b></p>	<p>2.1. The Promotional Period shall commence on the date hereof and shall continue in effect until such time as Fusion Markets, in its sole discretion, elects to terminate the Promotion, subject to prior notice being provided to participants.</p>
<p><b>3. Promoter</b></p>	<p>3.1. The Promotion is organised by Gleneagle Securities Pty Limited trading as Fusion Markets EN (hereinafter referred to as "we," "our," "us," or "Fusion Markets"), a registered Vanuatu Company and is regulated by VFSC, company number 40256.</p>

<p><b>4. Offer</b></p>	<p>4.1. The RAF offer consists of two distinct streams:</p> <p>4.2. <b>Reduced Commission Stream</b> - A Referrer may become eligible for a discount on trading commissions contingent upon the number of active referrals, as follows:</p> <p>4.2.1. 5 Active Referrals: 5% discount</p> <p>4.2.2. 10 Active Referrals: 10% discount</p> <p>4.2.3. 15 Active Referrals: 15% discount</p> <p>4.2.4. The reduced commission will reset every 12 months on a rolling basis for each referee. The 12-month period will begin from the date each referee was referred.</p> <p>4.2.5. The reduced commissions shall be credited daily to the client's trading account.</p> <p>4.3. <b>Bonus Stream</b> - Referrer and their referees can both receive a bonus based on the first deposit and trading activity:</p> <p>4.3.1. First deposit of \$500 USD (or equivalent): both Referrer and Referee receive \$50 USD each. The Referee must trade a minimum of 5 lots for both parties to qualify for this bonus.</p> <p>4.3.2. First deposit of \$5,000 USD (or equivalent): both Referrer and Referee receive \$250 USD each. The Referee must trade a minimum of 50 lots for both parties to qualify for this bonus.</p> <p>4.3.3. The bonus shall be applicable only to the Referee's first deposit.</p> <p>4.3.4. Bonuses are paid out after a 30-day holding period.</p>
<p><b>5. Eligible Client</b></p>	<p>5.1. To be eligible, you must comply with these Offer Terms:</p> <p>5.1.1. You must open an Approved Account with Fusion Markets</p> <p>5.1.2. This Promotion will be valid for clients registered under our VFSC license only.</p> <p>5.1.3. Referrer can only select one stream (Reduced Commissions or Bonus Payment) at any point in time.</p> <p>5.1.4. If a Referrer wishes to switch from one stream to another, they must inform us in writing and obtain approval.</p>

<p><b>6. Eligible Trades</b></p>	<p>6.1. <b>Reduced Commission Stream:</b> the discount applies to all trading activities of the Referrer if you have the required number of active referrals.</p> <p>6.2. <b>Bonus Stream:</b> the referee must trade at least 5 lots for both the referrer and referee to qualify for the bonus.</p> <p>6.3. Unless otherwise communicated by us via email, the following trading pairs are eligible for this offer: AUDCAD, AUDCHF, AUDJPY, AUDNZD, AUDUSD, CADCHF, CADJPY, CHFJPY, EURAUD, EURCAD, EURCHF, EURGBP, EURJPY, EURNZD, EURUSD, GBPAUD, GBPCAD, GBPCHF, GBPJPY, GBPNZD, GBPUSD, NZDCAD, NZDCHF, NZDJPY, NZDUSD, USDCAD, USDCHF, USDHKD, USDJPY, XAUUSD and XAGUSD</p> <p>6.4. Exotics, commodities, indices and cryptocurrencies are not eligible for this offer.</p> <p>6.5. Eligible Trades must be open for a minimum of 5 minutes. There can be no “Churning”. Trades must be placed by the Referee who is participating in this Offer.</p>
<p><b>7. Further Terms and Conditions</b></p>	<p>7.1. We will not be held liable for any losses incurred by you as a result of your trading in relation to your account(s). All trading involves risk and you are responsible for managing your positions and exposure.</p> <p>7.2. Fusion Markets reserves the right, in its absolute discretion, to revoke or withdraw this Promotion, together with any obligations arising therefrom, from any participant who, in the judgment of Fusion Markets, has abused or sought to abuse the spirit or intent of the Promotion. Fusion Markets further reserves the right to cancel, amend, or withdraw the Promotion at any time where it suspects abuse, without prior notice.</p> <p>7.3. If, at any time all, or any part of any provision of these Terms and Conditions are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) shall not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Rules or the legality, validity or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Terms and Conditions.</p>

Fusion Markets is the sole arbiter of this Promotion and reserves the right, in its sole discretion, to modify, suspend, withdraw or terminate the Promotion (or part thereof) at any time without prior notice and without liability to you.</p> <p>7.5. If you are discontinued from this promotion due to account inactivity, misuse, or failure to meet trading requirements, including at our sole discretion, you will need to sign up again if you wish to participate.</p> <p>7.6. Bonuses cannot be transferred to another person, another person's trading account, redeemed for cash or exchanged for other goods and services.</p> <p>7.7. This Offer can only be claimed once per household.</p> <p>7.8. You can only refer the same person once. You cannot refer yourself via a joint account, a family member or a member of the same household.</p> <p>7.9.
