#### **WEBSITE PRIVACY POLICY**

Fusion Markets International Ltd (Fusion Markets) operates fusionmarkets.com/sey and may operate other websites. It is Fusion Markets' policy to respect your privacy regarding any information we may collect while operating our websites.

#### **WEBSITE VISITORS**

Like most website operators, Fusion Markets collects non personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Fusion Markets' purpose in collecting non-personally identifying information is to better understand how Fusion Markets' visitors use its website. From time to time, Fusion Markets may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Fusion Markets also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on Fusion Markets' blogs/sites. Fusion Markets only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## GATHERING OF PERSONALLY-IDENTIFYING INFORMATION

Certain visitors to Fusion Markets' websites choose to interact with Fusion Markets in ways that require Fusion Markets to gather personally-identifying information. The amount and type of information that Fusion Markets gathers depends on the nature of the interaction. For example, we ask visitors who sign up at Fusion Markets provide a username and email address. Those who engage in transactions with Fusion Markets are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. #### AGGREGATED STATISTICS

## PROTECTION OF CERTAIN PERSONALLY IDENTIFYING INFORMATION

Fusion Markets discloses potentially personallyidentifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Fusion Markets' behalf or to provide services available at Fusion Markets' websites, and (ii) that have agreed not to disclose it to others.
