#### WEBSITE PRIVACY POLICY

Gleneagle Securities Pty Limited (Gleneagle) operates fusionmarkets.com/en and may operate other websites. It is Gleneagle's policy to respect your privacy regarding any information we may collect while operating our websites.

#### **WEBSITE VISITORS**

Like most website operators, Gleneagle collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Gleneagle's purpose in collecting non-personally identifying information is to better understand how Gleneagle's visitors use its website. From time to time, Gleneagle may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Gleneagle also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on Fusion Markets' blogs/sites. # GATHERING OF PERSONALLY-IDENTIFYING INFORMATION

Certain visitors to Gleneagle's websites choose to interact with Gleneagle in ways that require Gleneagle to gather personally-identifying information. The amount and type of information that Gleneagle gathers depends on the nature of the interaction. For example, we ask visitors who sign up at Fusion Markets provide a username and email address. # PROTECTION OF CERTAIN PERSONALLY IDENTIFYING INFORMATION
